The Draft Law registered on 29.01.2015 under No.1888, which basically implements total governmental control over each terminal (mobile phone) and each unit of end user equipment used in the telecommunications network using technical and human resources of communications service provider. The following procedures are implemented: procedures which will affect the person’s right to possess and use its property (radioelectronic facilities/radiating devices, electronic devices, mobile terminals), to use them as intended (as an instrument for unhampered obtainment of telecommunication services) which may further lead to infringement of rights of citizens as owners of communication terminals (including bona fide purchasers), as well as consumers of telecommunication services.
